


Opening and Blessing of MMC office at 1 Dawson, Street, Brunswick







On 30 May 2022, the Mercy Ministry Companions' inaugural office at 1 Dawson Street, Brunswick, was opened and blessed by most Reverend Dr Terry Curtin, Auxiliary Bishop of Melbourne and Episcopal Vicar for Evangelisation and Mission.

In the presence of the MMC Trustee Directors, representatives of the ILT, neighbours in the Marist Centre, a number of Sisters of Mercy and ministry staff from the MMC office and the ISMAPNG office at Alphington, the office was officially opened and blessed. Many of those who attended had made significant contributions in establishing and supporting Mercy Ministry Companions.

Of particular note was the attendance of Joan Wilson RSM, the last Mercy sister Principal at Saint Ambrose's primary school which is the same site and building upon which MMC resides. Sr Joan was amused to note that her office was in the same space as the current MMC office.

The Trustee Directors participated in the opening ceremony and prayers. A welcoming speech by the MMC Chair, Margaret Bounader, included a brief history of the site and its connection to the Mercy Sisters. Following the blessing of the office and official cutting of the ribbon, an enjoyable morning tea was served.

We were also very pleased that so many of our friendly fellow Catholic ministries located at the Marist Centre, who have made us feel so welcome, could join us for the opening.

Justin Clancy, local NSW member for Albury, and Kylie King, Mayor of Albury, attended the opening, along with several sisters of Mercy, Mercy Connect staff, and a number of other participants who were warmly welcomed to country by Daniel who also played his didgeridoo as part of the ceremony.

CEO Jocelyn Bignold OAM said the funding is 'giving us the confidence to build the full suite of wrap around support into this model.



This includes working closely with partners to provide legal, financial and health support and expanding the reach of McAuley's skill development, social inclusion, employment and child education support services, all underpinned by being in a safe place to rest and think.'

# Consultation document exploring processes for reporting on 'formation for mission' within MMC

In February/March, a mapping exercise was conducted to identify 'formation for mission' responsibilities contained in core documents and to map current procedures used by ministries and Boards when reporting on their various ongoing formation activities. A rich amount of information was shared. Emerging from the mapping were 6 six key themes, now outlined in a document drafted for consultation with ministries, Boards and Trustee Directors. The document, entitled "Sustaining an effective environment for enhancing 'formation for mission' within Mercy Ministry Companions" has been circulated for feedback. It is hoped that, after considering the feedback in mid-July, an agreed reporting process can be trialled for 12 months within MMC and then reviewed.
